#### **10. DISCUSSION AND VOTE TO AUTHORIZE CVEC BOARD OF DIRECTORS PRESIDENT TO** NEGOTIATE BRINGING TATSIANA NICKINELLO ONTO CVEC STAFF AS AN AT-WILL EMPLOYEE TO SERVE AS THE OFFICE SERVICES MANAGER WITH A SALARY NOT TO EXCEED AN APPROVED DOLLAR VALUE

L. Argo noted that, as discussed at the previous Board meeting, T. Nickinello is giving CVEC more hours, and it would be appropriate to bring her as a staff member and not a "1099". After the deliberation it was suggested not to put a certain dollar value, but rather work out an agreement with the consideration of the current budget. L. Cakounes commented that in his opinion a new President should have an ability to hire people as non-contractual employees. The Board, he added, can reaffirm the President's decision if needed.

The staff was tasked with providing a job description prior to hiring.

Rand moved the Board of Directors to authorize CVEC Board of Directors' President to negotiate bringing Tatsiana Nickinello onto CVEC staff as an at-will employee to serve as the Office Services Administrator with a salary not to exceed a budgeted dollar value, seconded by L. #### **11. RELATIVE TO CVEC STAFF ELIGIBILITY AS PUBLIC EMPLOYEE RETIREMENT ADMINISTRATION COMMISSION (PERAC), DISCUSSION AND POSSIBLE VOTE ON CVEC SEEKING LEGISLATION TO ADD TO CVEC'S FORMATIVE DEFINITION THAT CVEC IS A GOVERNMENTAL ENTITY**

L. Argo reminded the Board that when CVEC was a division of Barnstable County, all employees could join Barnstable County Retirement Association. Later, when CVEC separated from the county and went out on its own, CVEC was not able to stay with PERAC. She continued and said that it will be seemingly beneficial for CVEC to return to PERAC. M. Marasco added that PERAC membership hinges on CVEC acquiring a defined classification as a governmental entity. L. Cakounes mentioned that CLC recently joined PERAC after they successfully became a Joined Power Entity. He said that CVEC can go straight to legislature in an attempt to seek a clear governmental entity status. L. Cakounes referenced an example of the case when the legislature overrode the retirement board. The discussion took place about joining PERAC. M. Marasco mentioned that the retirement system provides a mechanism for health insurance and death benefits in a more comprehensive package. Potential liability question was brought up. It was determined that the Barnstable County Retirement Board is a completely separate entity that oversees retirement investments, and towns have no obligations to pay CVEC employees' salary. M. Marasco said that currently there is no clarity as to CVEC's status. The IRS considers CVEC a corporation, but CVEC pays no taxes. DPU and DOER considers CVEC a public entity. A. Prince noted other avenues to achieve the same goals such as exploring 403 b, 457 b or other options that can be potentially arranged regardless of the status change. L. Cakounes argued that

as CVEC moves forward it is likely that new employees may be drawn from municipal employees' pool. He added that joining PERAC may turn to be not a money saving move, but rather a more convenient option strategy wise. It was discussed that becoming a joint power entity is a rather lengthy and expensive process. M. Marasco said that a draft on the legislation is ready for the review. S. Lewenberg agreed noted that becoming a part of the retirement board will improve CVEC's ability to attract best talent as the organization is gearing up to be a more professional entity with more employees.

# **12.** DISCUSSION AND POSSIBLE VOTE ON CREATION OF CVEC POLICY TO GUIDE CVEC STAFF AS TO PARTICIPATE IN POLITICAL, ACTIVIST, EDUCATIONAL OR REGULATORY ORGANIZATIONS, AND/OR TO SUPPORT LEGISLATIVE INITIATIVES

L. Argo reported that currently there is no policy guiding CVEC on whether to join or not to join a certain organization, etc. She said that in the past CVEC joined two market industry associations, however, some of them may have political organizations as members. She added that CVEC is also on Cape Cod Climate Change Collaborative advisory board, as previously voted in favor by the Board. L. Cakounes said that he strongly believes, as a volunteer appointed by our member towns, in steering this organization away from a certain direction. He added that he does not believe there is a policy that would allow for staff to commit this organization to one thing or another. The Board asked staff to put together a list where CVEC is a member/consultant, etc. J. Rand said that she does not believe staff should be writing a letter of support or, moreover, any letters of endorsements or letters for legislator, as CVEC is comprised of a very diverse group.

#### **<u>13. UPDATE ON PROJECTS:</u>**

• Round 3 batteries

L. Argo reported that earlier there was no feasible solution for retrofitting batteries in the existing projects, but there is a solution now. She added that for large projects, however, there is still no reasonably priced solution at this time.

• Round 4 – first project has broken ground

L. Argo reported that Round 4 is fully contracted to deliver 12MW. She added that first project broke ground and is scheduled to be interconnected in the next few months. The acknowledgments are mostly completed as well. L. Argo and C. Hanson are to attend Brewster Planning Board meeting addressing aesthetic look of the project.

• Round 5

L. Argo reported that Round 5 projects are all contracted with permitting under way. She added that projects landed in SMART good blocks to maximize benefits.

• Round 6

L. Argo reported that Martha's Vineyard Airport seem to back out from participating in CVEC Round 6. She added that Orleans is reassessing as well. Yarmouth DPW is going with different model: they are hiring a firm to engineer a project and deliver it as an RFP. L. Argo mentioned that CVEC might not be able to help with this model.

• DY High School battery

L. Argo reported that CVEC received and signed the state contract. She added that CVEC is waiting on the state to sign and send it back. Meanwhile, L. Argo is to give a presentation to DY on the battery and talk to Ameresco as they are working on altering their agreement to embrace the phase nature of the contract with the state.

• Yarmouth Town Management and Report

L. Argo went over the report created using CVEC's Database pertaining to the Town of Yarmouth electric accounts. She explained that using the database, CVEC can better distribute net metering credits to the accounts. She added that the program is a comprehensive tool to target share allocations that is capable of delivering a status snapshot to fine tune the management of the net metering credits.

#### **<u>14. DIRECTORS' REPORTS</u>**

The Directors agreed that they feel comfortable with L. Cakounes continuing performing a consulting role in a lot of pending matters, for example an upcoming employment evaluation. The Directors' thanked L.

Lewenberg mentioned that Chilmark is in final stages of Public Works building initiative. Steve S. Gavin thanked L. Cakounes and noted that L. Cakounes made organization strong and professional, while keeping focus on goals and responsibilities. A. Strahler said that Edgartown is to vote for passing stretch code at the next town meeting. A. Prince reported that Eastham is moving forward with two EVs and a charging station as well as pushing forward towards Green Community designation. He added that Eastham's new Assistant Town Administrator Rich Bienvenue shared with him the enthusiasm to work with CVEC on the next round of solar, potentially resulting in some significant movement with solar development in town. J. Marks thanked M. Marasco and L. Argo on offering to meet with Bourne town officials to help move Bourne on getting Green Community designation. R. Dreger-Carey said that Falmouth town meeting declared a climate emergency and adopted the stretch code last town meeting. She added that M. Marasco was included on communication with the Town Manager, and, as a result, a meeting with school committee will be scheduled to discuss opportunities for solar.
