4. Treasurer's Report

a. Financial Report Ending March 31, 2022

Bob Wirt presented the financial report. The highlights of the report are: CVEC has a balanced budget, sufficient reserves to continue to proceed as planned. Executive Director Maria Marasco added that the audit is near completion. She thanked the staff for their contributions and hard work. **Director's Report**

b. **CVEC Operations**

Executive Director Maria Marasco reported about several CVEC changes that transpired in FY22. CVEC brought bookkeeping in house that was previously outsourced, revised the accounts, which allowed to produce internal production reports bringing consultant costs down.

c. DOER Grant/DYRSD DY HS Project Status and Discussion

Executive Director Maria Marasco reported that approximate turn on date is set at the end of the year. CVEC received first payment installment from DOER in August 2022.

d. US Inflation Reduction Bill and MA Act Driving Clean Energy and Offshore Wind- Highlights and Opportunities

Executive Director Maria Marasco reported that CVEC falls into several categories as a governmental entity and a cooperative under Inflation Reduction Act which opens new opportunities. CVEC would potentially be able to issue bonds under MASS development. New Program Committee is evaluate new options that will be available for CVEC.

5. Project Reports

a. Status of Rounds 4, 5 and 6 Projects

The Executive Director reported that meeting is scheduled for Round 4 and 5 projects to discuss additional costs. CVEC's contracts state that in the event interconnections costs exceed \$10K there is an opportunity that allows renegotiations.

Maria Marasco noted that although Round 6 got cancelled, all of the projects now may qualify for new incentives. She added CVEC's effort attracted attention from one of the Massachusetts large universities that may be added to new round to make it more robust and more attractive for all of the participants.

b. Battery Storage Discussion

The Executive Director Maria Marasco updated the board that CVEC conducted conversations with Yarmouth Fire Chief to provide safety for students and school staff regarding DY battery. Town has no objections to the project. The board was informed on 3 level fire suppression systems used by the fire department.

6. Other Business

Steve Lewenberg had a question regarding CVEC EV program that was put on hold during covid lockdown period. It was recommended to reach out to Green Consumer Energies for expert advise.
